UPDATE - CITY OF SENECA SERVICES

-Essential services including

Police, Fire, and Public Works to continue as normal

-City buildings closed to public access at least through April 15th

-Drive-through windows open for payment

-Payments, licenses and permits by telephone or online

The City of Seneca is joining many other businesses and government offices that have decided to make changes in their working environment and operations in the face of the COVID-19 pandemic. The City provides necessary and vital services for our citizens and surrounding communities that impact their lives on a daily basis. It is of paramount importance to us that the services and operations citizens depend upon are available to them when needed, while at the same time we know we must keep our workforce healthy and ready to respond to any situation that may arise.

After thoughtful planning and consideration, we have incorporated CDC recommendations within the city government structure to observe travel bans, event cancellations, social distancing, limiting public access to the city's public buildings, postponing any community educational activities, and alteration of bus routes and bus stops.

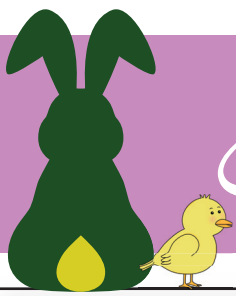
NOTES TO SENECA PUBLIC WORKS CUSTOMERS

If you have a business inside the city limits of Seneca, please contact Seneca City Hall about obtaining a business license or renewing your 2020 Business Licenses. All Renewal Applications for 2020 have been mailed out. The due date for renewals has been extended until June 1st.

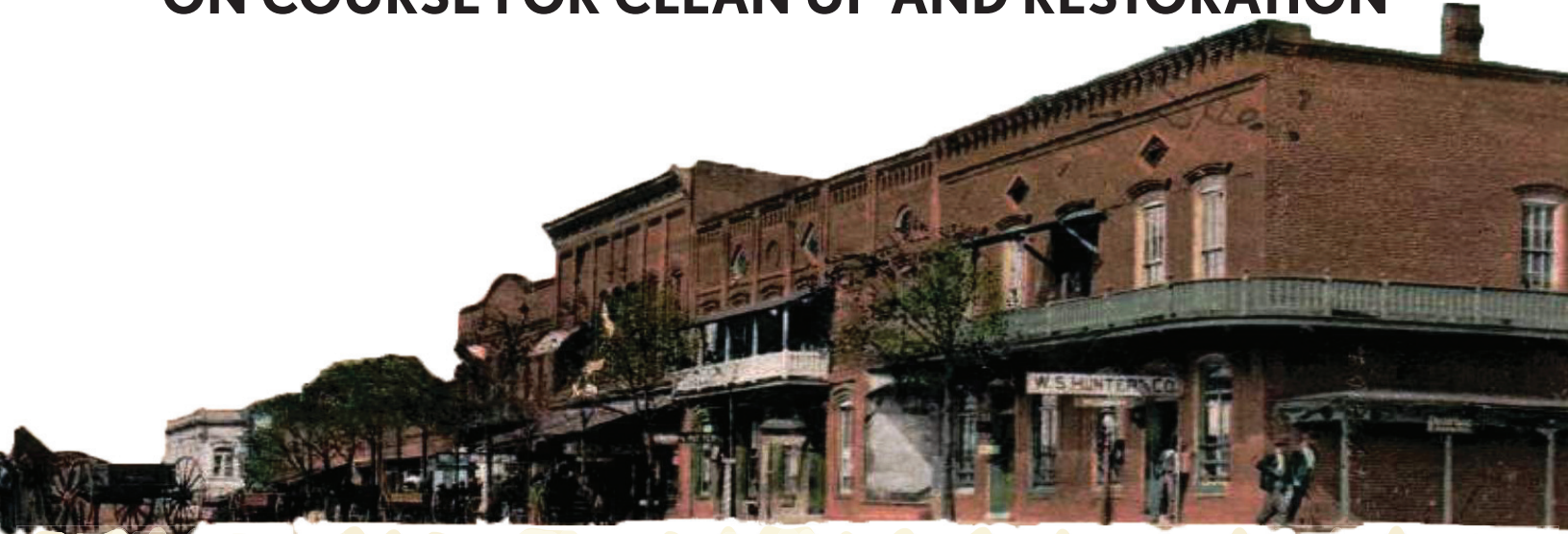

HARPER BUILDING IN DOWNTOWN SENECA ON COURSE FOR CLEAN UP AND RESTORATION



During the final days of March, workers converged on the Harper Building in downtown Seneca to begin asbestos abatement (removal).

Abatement of environmental hazards is the first step in preparing the building for future renovation.

The process will take about three weeks. Workers will then immediately relocate to the former Belk/Kimbrell building for asbestos removal there as well.

The City is currently in the preliminary phase of reconstruction design.
