## Show Agreement

Peachtree Laser, Inc. will provide laser lighting equipment and services to the City of Seneca, SC for one Memorial Day show May 23, 2020. Setup will begin on May 22, 2020.

Equipment provided by Peachtree Laser will include four 20-watt full-color RGB diode lasers for aerial effects, and one 6-watt, full-color RGB diode laser and projector for full color laser graphics, plus all associated electronics necessary to produce computer designed scanned images and aerial effects. Aerial effects will include arrays of elaborate beam matrices, scanned planes and cones, and diffraction effects. Custom laser graphics will include up to 10 custom logos and preprogrammed patriotic laser modules. A 17' x 30' inflatable screen will be included. The show will run approximately 15-20 minutes. Two diffusion fog machines will also be included. The total price for all of the above will be \$ 13,000.00.

Peachtree Laser will provide experienced operators, all set up and operation, a show soundtrack, and all federal and state permits. The City of Seneca will provide (5) 20 ampere, 110 VAC single-phase electrical circuits and a sound reinforcement system to play the show soundtrack from Peachtree Laser's computer. Two additional 20-amp services will be required for the inflatable screen. Peachtree Laser will provide all transportation for its equipment and personnel. The City will provide 3 single hotel rooms for the technicians the nights of May 22 & 23 and security for the laser equipment the night of May 22.

This agreement may not be canceled, however Peachtree Laser will honor a substitute date, schedule permitting. A deposit of \$ 2,000.00 is payable upon the signing of this agreement, with the balance due May 23 at the conclusion of the show. This agreement must be signed and returned to Peachtree Laser by February 24, 2020.

## Peachtree Laser Technical Requirements

### Technical Requirements for Lasers:

[x] Graphic effects laser (6-watt full-color RGB diode):

(1) 20 ampere, 110 VAC, single phase service at truss mounting point for laser

[x] Aerial effects lasers (20-watt full-color RGB diode):

(4) 110 VAC 1-phase, 20 ampere power supplies (actual power consumption is ~ 7 amps)

### Additional:

[X] security (or secure site) for equipment while laser crew is not present

[ ] personnel lift or ladder for hanging lasers

[X] sound system suitable for audience; Peachtree Laser will provide playback source

[N/A] Clear-Coms or some suitable means of communicating with show director

[x] (1) additional 20 ampere 120 VAC single-phase circuit near laser graphics station

[x] (2) additional 20 ampere 120 VAC single-phase circuits near inflatable screen

\*\* Peachtree Laser, Inc. will perform all necessary notification of the FAA & FDA Center for Devices and Radiological Health.

\*\* All aerial laser effects must clear audience by 2.5 meters horizontally and 3.0 meters vertically.

\*\* Venues should be notified of our intent to use light theatrical fog, specifically a DF-50 fog machine, which creates a light haze, and *generally* does not trip smoke detectors.
