ORDINANCE NO. 2022-04

AN ORDINANCE TO AMEND THE CITY OF SENECA'S BUSINESS LICENSE ORDINANCE TO CORRECT AN OMISSION IN APPENDIX A: BUSINESS LICENSE RATE SCHEDULE

WHEREAS, in September 2020 the South Carolina General Assembly adopted the South Carolina Business License Tax Standardization Act (2020 Act No. 176), now codified at S.C. Code Sections 6-1-400 to 6-1-420 (the "Act"); and

WHEREAS, the City of Seneca ("City") passed Ordinance 2021-17, an ordinance to adopt a revised business license ordinance in accordance with the Act, on January 11, 2022; and

WHEREAS, Rate Class 8.6 was inadvertently omitted from Appendix A: Business License Rate Schedule of the business license ordinance passed by Ordinance 2021-17; and

WHEREAS, the City desires to amend Appendix A: Business License Rate Schedule to correct this omission prior to the adopted ordinance becoming effective beginning with the business license period commencing on May 1, 2022.

NOW, THEREFORE, upon motion of City Council, and BY CITY COUNCIL, in council duly assembled, and with a quorum present and voting, BE IT ORDAINED that the Council of the City of Seneca hereby amends Appendix A: Business License Rate Schedule to include Rate Class 8.6 as reflected on Exhibit A attached hereto. All other provisions of the business license ordinance adopted by Ordinance 2021-17 on January 11, 2022, remain in full force and effect. The attached Appendix A: Business License Rate Schedule shall become effective, along with the business license ordinance adopted by Ordinance 2021-17, with the business license period commencing on May 1, 2022.
